Eligibility

This contest is open to individuals of any age who have Down syndrome.

Artwork Requirements

1. If you are an artist with Down syndrome, create an original t-shirt design by hand or by computer using your choice of art - you can use any medium! If you create the design by hand, it should be illustrated on plain, unlined, bright white paper.
2. Your design may use a maximum of 3 colors. Black is included in the three.
3. Your design must be your own original unpublished work and must not contain any third-party logos, trademarks, or copyright materials.
4. All artwork must be no smaller than 6" x 6" and no larger than 8.5" x 11"
5. All digital images should be submitted in high resolution (300 dpi or greater).

Deadline for Entries

Entries must be received by September 1, 2017

Submission

Entries may be submitted by mail or email to DSIA. The official entry form must be submitted with every entry.
